Whereas, the State Election Commission has issued schedule for preparation of electoral roll vide Order No. 3677/SEC., dtd.18.10.2016, 4409/SEC., 10.11.2016 & 4490/SEC dtd.16.11.2016 excluding some Gram Panchayats mentioned therein in Ganjam, Balasore, Kalahandi and Nuapada district due to non-finalisation of cases on reorganization of Gram Panchayats;

Whereas, the Commission on the proposal received from concerned Collector has excluded further some Gram Panchayats from the above order vide Order No. 3774 dtd.24.10.2016, 3781 dtd.24.10.2016, 4014 dtd.27.10.2016, 4267 dtd.03.11.2016, 4279 dtd.03.11.2016, 4291 dtd.03.11.2016, 4298 dtd.03.11.2016 and 4462 dtd.15.11.2016 in Balasore, Ganjam, Deogarh, Bolangir, Rayagada and Boudh;

Whereas, the Gram Panchayats excluded from the preparation of electoral roll district-wise is appended in **Schedule-I**;

~~Whereas, in the mean time some cases on re-organisation of Gram Panchayats have been finalized and Delimitation of Wards and Reservation of Seats have been completed by the concerned Collectors;~~


Whereas, it is necessary to prepare Ward-wise electoral roll of those excluded Grama Panchayats whose Delimitation of Wards and Reservation Seats have been finalized by the Collector concerned after finalization of the cases;

Now, therefore, the State Election Commission, in exercise of powers vested by virtue of Article 243-K of the Constitution of India read with relevant provisions of Odisha Grama Panchayat Act, 1964, Odisha Panchayat Samiti Act, 1959 and Odisha Zilla Parishad Act, 1991 and Rules framed there under directs that Ward-wise electoral roll of concerned Grama Panchayats shall be prepared in Form No.1 as per the programme in **Schedule-II** appended herewith.

Other procedure for preparation of electoral roll communicated vide Commission's Orders mentioned above shall remain unchanged.


